Complete original procurement documents in English can be obtained from the undersigned or via email upon submission of a written request on company letterhead, signed by an authorized representative, **on working days between 0900 hrs. and 1400 hrs. (IST) until Monday, 14<sup>th</sup> July 2025**, upon payment of a nonrefundable fee of **Sri Lankan Rupees Fifteen thousand (LKR 15,000.00)** or **United States Dollars Fifty (USD 50.00)** per document.

Bidders are advised to review the procurement document before purchase, as the procurement document fee is non-refundable under any circumstances.

A **pre-bid meeting** will be held via video conference at 1000 hrs. (IST) on **Monday, 23<sup>rd</sup> June 2025**, to address any queries related to the procurement document. Prospective bidders or their authorized representatives are invited to attend. **Bids will close at 1400 hrs. (IST) on Tuesday, 15<sup>th</sup> July 2025,** and will be opened immediately thereafter at the office of the Manager (Procurement) in the presence of authorized representatives of the bidders who choose to attend. Only one authorized representative per bidder may attend the bid opening.
